Hereinafter referred to as "Buyer" and Kitsy Seveland of Old West Australian Shepherds Hereinafter referred to as "Seller" voluntarily enters into and agrees to all terms delineated in this contract as witnessed by their signatures below.

I.) Buyer understands that Puppy has been sold with **LIMITED American Kennel Club (AKC) and Australian Shepherd Club of America (ASCA) registration**. Limited Registration means that the dog is registered but no litters produced by that dog are eligible for registration.

II.) Buyer agrees to take all measures necessary to insure that Puppy is not mated, and does not have the opportunity to sire or deliver a litter or litters.

III.) Buyer agrees that Puppy will be spayed/ neutered within 2 years after purchase . Please do NOT spay/ neuter before 1 year of age. (see links on my website for information)

HEALTH GUARANTEE

I.) Seller guarantees that Puppy is in good health and has received appropriate medical inoculations and care including parvo inoculations and worming. Seller will provide Buyer with a medical chart detailing treatment Puppy has received under Seller's care and future care Seller feels is essential to Puppy's well being.

II.) Seller guarantees that Puppy is free of life threatening diseases or disabilities (i.e. parvo, etc.) for 7 days after delivery to Buyer. Should life threatening diseases or disabilities be discovered by Buyer within 7 days of receipt of Puppy, and attested to in writing to Seller by Buyer's veterinarian, Seller will provide Buyer with a replacement pet quality puppy of the same sex and color as soon as such a puppy is available to Seller. Seller strongly recommends that Buyer have Puppy examined by a licensed veterinarian of Buyer's choice within 1 week of receipt of Puppy.

III.) Should at any time the buyer chooses to sell or place this puppy with a new owner, the seller/breeder must first be notified and given right of first refusal. The seller/breeder is in no way is responsible to purchase the puppy back. We will however take the dog back to be re-homed. Signed papers must accompany the dog upon return.

IV.) This puppy is sold solely as a pet with no guarantee other than those stated in the above paragraphs.
